### **Decree B.E. 2558 and Royal Decree 595 B.E. 2558 - asv.co.th**

This Emergency Decree is called “the Emergency Decree on Fisheries B.E. 2558 (2015)” Section 2. B.E. 2558 (2015). (8) Royal Decree on Establishment of Rubber Estate Organisation (No. 3), B.E. 2535 (1992). Section 4.
