Dissolution of firm may take place in the following manner. A firm may be dissolved with the consent of all the partners [Section 10, Partnership Act], the agreement of Partnership deed vague & doubtful w.e.f. _____. Dissolution of a firm is the process by which legal existence of the firm comes to an end.

Format of Dissolution Deed

Deed of dissolution of a general partnership involving a winding up of the partnership and the sale of assets to a third party and where the business carried on by the partnership will not be carried on after dissolution in any form by any of the partners.

Deed of dissolution of a general partnership: business

excluding therefrom the debts and liabilities of the Firm. AND WHEREAS each partner is entitled to an equal share in the assets and profits of the firm, under the said Deed of Partnership.

The Deed of Partnership must be executed on a stamp paper of prescribed value. The copy of the deed must be sent to the Registrar of Partnership Firms along with the prescribed form duly completed for issue of ACKNOWLEDGEMENT of firm.
