A Quit Claim Deed transfers the ownership or rights of property from a seller, or 'Grantor', to a buyer, or 'Grantee'. This type of deed only transfers the rights of the real property from the current owner (if the 'Grantor' is the owner) and makes no guarantees about the title in regards to past owners.
